# Scottish League Re-elections and Elections

The date given is when the League AGM was held.

N/A denotes that the club was not affiliated to any league competition.

The original rule was for the bottom three clubs to retire and make a new application to re-join the League, in competition with other non-League sides. This was reduced to the bottom two clubs from the 1898-99 season.

The competition got off to an inauspicious start after Renton were suspended by the Scottish FA for playing Edinburgh Saints, a team consisting of players banned for professionalism while with St Bernard's. Renton, having played four fixtures, therefore couldn't fulfill the rest until the ban was lifted in December and so were excluded from the competition. They returned in 1891-92.

Dundee were an amalgamation of two Northern League clubs, Our Boys and East End. They and Renton both gained 12 votes out of the 14 available. After Abercorn were excluded, their votes were transferred to St Bernard's in the second ballot.

On 7 July 1893, the League decided to form a Second Division. The Scottish Alliance, the principal non-League competition, wanted its members to form the new section but the League themselves took on the responsibility of selecting the clubs. On 10 July, Abercorn and Clyde, who were not re-elected at the initial AGM, above, were granted a place in the new section, as was Hibernian. The Easter Road club had recently reformed after taking a break for a couple of years.

Cowlairs, Morton, Partick Thistle, Port-Glasgow Athletic, Northern and Thistle (all Alliance) and Motherwell (Scottish Federation) were also selected to form the new division. The other members of the Alliance; Kilmarnock, Linthouse, Airdrieonians and Cambuslang, were all refused.

Thistle, who finished bottom of the Second Division, didn't apply for re-election.

Cambuslang, Albion Rovers and Wishaw Thistle of the Alliance, and Raith Rovers who were non-affiliated, didn't figure in the voting as they couldn't find a seconder.

Dundee Wanderers were formed by the merger of Johnstone Wanderers and Strathmore, both of the Northern League. Airdrieonians, despite finishing bottom of the Alliance championship as shown below, were elected ahead of Royal Albert who could only muster 11 votes, 8 fewer than Airdrieonians.

Wishaw Thistle were formed in 1885 moving into Recreation Park in 1888. They competed in the Scottish Federation from 1891 to 1893 before joining the truncated Alliance which they won twice. Another move in 1896 saw them join the Scottish Combination. This was very much a disaster as they finished bottom in three of the four seasons they competed. In May 1900, a merger with rivals Wishaw saw a new club at Recreation Park, Wishaw United. After securing a place in the Combination, they improved slightly on the previous seasons, but midway through the 1902-03 campaign, they resigned from the league and disbanded soon after. Recreation Park didn't stay empty for long though as Wishaw Amateurs took up the challenge, joining both the Midland and Scottish Amateur Leagues. In 1906 the Amateurs changed their name to Wishaw Thistle, and it was this club that finally found a place in the Scottish League via its Third Division expansion in the 1920s.

#### The resignation of Renton

On 20 October 1897, during the 1897-98 season, Renton resigned for financial reasons. They couldn't meet the  $\pounds 10$  guaranteed gate money for visiting clubs, and as they had played only four fixtures, it was decided to elect a replacement club to fulful the remaining matches. A proposal that the division carried on with nine clubs was rejected and it was decided to consult with Hamilton Academical, Albion Rovers, East Stirlingshire and Falkirk to ascertain if they were willing to fill the vacancy. Three other clubs that applied for the place were deemed unsuitable and were dismissed. On 27 October, Hamilton were elected, after which they tendered their resignation from the Scottish Combination, having to pay a  $\pounds 20$  penalty in the process.

While Raith Rovers finished bottom of their league - the East of Scotland League was a 'supplementary' league for the main eastern based Scottish League clubs - Arthurlie were runners-up behind Rangers 'A' in the Combination, and Orion and Dundee Wanderers were in the first two places of the Northern League.

This was Orion's only application. In 1903 a merger with Aberdeen and Victoria United saw the formation of the present Aberdeen club.

After leaving the League, Linthouse were practically defunct. They did enter the Qualifying Cup the following season, gaining a bye in the first round before scratching to Motherwell.

Partick Thistle beat Clyde on lots to decide who played in the First Division in 1900-01. St Mirren had earlier beaten St Bernard's 2-1 at Dens Park on 7 April in a decider for the second re-election place.

# Queen's Park's admission to the First Division

A difference of opinion over the voting powers of Second Division clubs saw a split in membership and the formation of a new body on 12 July 1900, to which Queen's Park accepted the invitation to join. At the time they were members of the 'supplementary' Inter City League. On the resolution of the dispute on 25 July 1900, Queens were allowed to retain their membership of the First Division. They therefore became the only club to bypass the Second Division and move directly into the First Division. Aberdeen failed to do the same a few years later and the Rule was later changed to stop it happening again.

Hamilton and Leith had finished level in eighth place in the Second Division but a proposed play-off at Merchiston Park in Falkirk a day before the League AGM was vetoed by the Scottish FA. Both clubs had to apply for re-election.

This extended vote saw the Second Division expand to fourteen clubs. Vale and Johnstone were both re-elected and Clydebank, who had only been formed the previous February were overwhelmingly elected despite their lack of competitive football. It's uncertain, though unlikely, whether Cowdenbeath, Leith or St Bernard's, the top three in Division 2, applied for promotion.

At a later meeting, the Second Division was suspended 'for the duration of the war'. Those involved plus a number of non-league clubs formed two regional leagues, the West of Scotland League and Eastern League. Despite not having a say at the League meetings, they were still viewed as being League members and were still required to pay they membership dues! The Second Division didn't re-form until 1921 after a brief 'war' between the Scottish and Central Leagues.

Between 1916 and 1921 there were no further re-elections held at the AGMs although Aberdeen, Dundee and Raith Rovers were asked to step down in 1917 to help reduce the travelling incurred by the rest of the clubs. Clydebank, the West of Scotland League champions, were offered a place to bring up the numbers to eighteen clubs and this was accepted at a League meeting on 6 June 1917. League runners-up, Stevenston United and Albion Rovers, who finished sixth out of nine clubs, were also interested in the vacancy if Clydebank had refused.

With Aberdeen, Dundee and Raith Rovers returning to the Scottish League in 1919-20 season, a vote was taken to fill the vacancy that was created. On 3 April 1919, Albion Rovers beat Cowdenbeath by 11 votes to 10 to take the position. Clydebank, who had been 'co-opted' in 1917, had their place in the League confirmed.

The 'First Division' now stood at a record 22 clubs, but the League as a whole was reduced after the Second Division, although not played since 1915, was dropped at the AGM on 2 June 1919. Abercorn, Arthurlie, Cowdenbeath, Dundee Hibernian, Dunfermline Athletic, East Stirlingshire, Johnstone, Leith Athletic, Lochgelly United, St Bernard's, St Johnstone and Vale of Leven, all lost their place.

Furious at what they saw as a betrayal, the eastern clubs formed the Central League. By not being members of the Inter League Board, these clubs could poach Scottish League players and not pay a transfer fee. This money would go direct to the players and a number of big name stars moved to the new league. The Scottish League initially waited out to see if the bubble would burst, but the Central League clubs grew in strength. Crowds went up as the fans flocked to see the big names play for their teams. By 1921 the Scottish League had had enough and a compromise was reached. The Second Division was to be reformed with automatic promotion and relegation, with the clubs listed below:

At the next League AGM on 16 May 1922, a proposal by Airdrieonians to maintain the 22-20 divisions which would have saved Queen's Park from relegation and Dundee Hibernian from dropping out of the League altogether failed. Thus the latter plus Clackmannan were consigned to the Scottish Alliance and Eastern League respectively after finishing in the last two places in the Second Division.

Re-elections were reintroduced in 1923 but suspended again until 1926 after the formation of, and subsequent collapse, of the Third Division.

The formation of the Third Division was debated at a Management Committee meeting on 18 June 1923 and ratified on 28 June. Eighteen clubs were invited but three of those didn't reply; Helensburgh (who did eventually join), Hurlford (who were practically defunct) and Leith Athletic (who didn't join until 1924). Arbroath Athletic were interested, but the League refused their application as Arbroath already had a League club despite Dumbarton, a town of similar size, now having two clubs.

Apart from Hurlford (see above) and Queen's Park Strollers, the entire West of Scotland League membership joined the new division while three clubs came from the Eastern League. These two leagues therefore became defunct. One club came from the Southern Counties League while East Stirlingshire, who dropped down after failing re-election, made up the numbers.

The Third Division therefore consisted of Arthurlie, Beith, Brechin City, Clackmannan, Dumbarton Harp, Dykehead, East Stirlingshire, Galston, Helensburgh, Mid-Annandale, Montrose, Nithsdale Wanderers, Peebles Rovers, Queen of the South, Royal Albert and Solway Star.

At a League meeting on 26 June 1924, Leith Athletic were admitted to the Third Division. This meant an increase to seventeen clubs but this was reduced again to 16 when Dumbarton Harp resigned because of financial difficulties on 10 January 1925. This was accepted by the League on 4 February when it was decided to expunge their results.

In April 1926, Galston intimated their intention to resign but were urged to continue. They hadn't actually completed any fixtures after 9 January and in any case the whole division collapsed at the end of the season. Beith, Brechin City, Clackmannan, Dykehead, Forfar Athletic, Helensburgh, Johnstone, Leith Athletic, Lochgelly United, Mid-Annandale, Montrose, Peebles Rovers, Royal Albert, Solway Star and Vale of Leven all eventually lost their membership and were taken into an expanded Scottish Alliance.

With no relegation taking place, the bottom two clubs therefore stood to apply for re-election.

An application from Bo'ness was refused as the AGM saw no beneficial reason for a change.

World War Two saw the suspension of the football season for a time, but in October 1939 the League restarted with two regional divisions of 16 clubs apiece. Edinburgh City, Montrose, Brechin City, Forfar Athletic, East Stirlingshire and Leith Athletic were not included in the new setup. Cowdenbeath had to resign just after New Year but as they had played each of the other clubs one, their record was allowed to stand. At the end of the season, the League suspended its competition until it restarted in 1946. Its member clubs were allowed to form their own leagues in the interim, namely the Southern League and North Eastern League.

# 1946-47

Upon its restart in 1946, the Scottish League had a new divisional set-up. There would be two sections, A and B with 16 and 14 clubs respectively and a third division, C, consisting of the remainder plus the reserve sides of a number of A and B clubs. Two clubs failed to survive the War; St Bernard's and King's Park, the latter's ground being destroyed during a bombing raid. They were replaced by Stirling Albion.

At the end of the season, 1946-47, Stirling Albion as Division C champions were promoted to Division B. They should have replaced Cowdenbeath who had finished bottom but it had already been decided to expand Division B to 16 clubs. Edinburgh City moved that Cowdenbeath were re-elected to the second tier and this was unanimously accepted. To decide the sixteenth club, a ballot was taken with five clubs in competition.

#### Applications for re-election

Between 1891 and 1951, the following clubs all applied for re-election to the League. Note that between 1916 and 1920, in 1922, 1924 and 1925 and from 1946 to 1949, there were no re-elections held due to the particular League setup that was operating. Also, because of resignations in 1894 (Thistle), 1900 (Linthouse), 1910 (Ayr Parkhouse), 1911 (Port-Glasgow Athletic) and 1929 (both Arthurlie and Bathgate), the number of clubs having to seek readmission was reduced by one in 1894, 1900, 1910 and 1911, and to none in 1929.

Most applications have come from Edinburgh City and Vale of Leven with seven each, Edinburgh's all coming in the 1930s. During this decade there was a lack of other applicants with the result being the bottom clubs were virtually guaranteed to be re-elected.

# Consecutive applications for re-election

Edinburgh City are also holders for the record of most consecutive applications, four times in 1932-1933-1934-1935. They also applied in 1937-1938-1939. Motherwell applied in three consecutive years 1896-1897-1898 as did Cowdenbeath 1908-1909-1910.

Vale of Leven applied four times in five seasons 1911-1912-1914-1915.

Most of the clubs which have applied for a League place have eventually been elected at one time or another. The formation of the Second and Third Divisions in the 1920s saw many of the formerly excluded clubs join. However there is a small group of clubs that have been denied a place over the years.

Clachnacuddin of Inverness failed in their application in 1960.

Cove Rangers of Aberdeen have applied three times, 2000, 2002 and 2008.

Dumfries applied in 1905. They merged with KOSB and Arrol Johnston in 1919 to form Queen of the South.

Edinburgh City, a different club from the one that existed from the 1930s to 1950s, have failed to be elected twice, 2002 and 2008.

Forres Mechanics applied for the vacant slot in 1974 but lost out.

Gala Fairydean have made the most applications of these clubs, four in total, 1966, 1994, 2000 and 2002.

Gateshead United are the odd ones out, being an English club. They were originally known as South Shields until 1974 when they made their bid.

Hawick Royal Albert tried and failed in 1966 and 1974.

Huntly, another Highland League club, made one attempt, in 2002.

Inverness Thistle also applied in 1974 but lost out to Ferranti Thistle (later Meadowbank Thistle, later Livingston) after a deciding ballot. In 1994 they merged with local rivals Caledonian to form Caledonian Thistle and be successfully elected into the Third Division.

Kirkcaldy United was the Lang Toun's other club but their 1913 application had no chance of success, Raith Rovers were Scottish Cup finalists and First Division members.

Mossend Swifts unsuccessfully applied for a place at the first election held in 1891.

Preston Athletic from Prestonpans in East Lothian have applied three times, 2000, 2002 and 2008.

Spartans given the esteem they are held in non-league circles, have surprisingly only applied once, in 2008.

Wishaw Thistle, not the club which entered the Third Division in 1923, this one existed in the 19th century and tried twice, 1895 and 1896.

Three other clubs tried to join in the 1890s, but were denied the opportunity when they couldn't find a seconder; Dundee County were formed in May 1896 after an upheaval at Dundee FC brought a complete change in the club's management structure. This prompted members of other clubs towards forming a new club. Dundee Wanderers had also shown a desire to include the old Dundee men. An application was made for admission to the 1896 AGM but when they failed to find a seconder for election they subsequently 'disbanded' without ever playing a game. The two Aberdeen clubs, Victoria United (1897) and Orion (1899) both failed in their attempts, but after a three way merger in 1903, the city eventually had a League member in the shape of Aberdeen FC.
